## TERMS AND CONDITIONS FOR TELEX REBATE PROMOTION:

1. By entering this Promotion, entrants agree to be bound by these Terms and Conditions.
2. The Promotion period will be September 1 until December 31 2020.
3. The Promotion is open to private persons only. To enter the Promotion as an individual, on behalf of a company under any circumstances is prohibited and will result in disqualification from the cashback Promotion.
4. A minimum purchase of 1 TELEX headset AIRMAN8+ during the Promotion time frame defined in paragraph 2 is necessary to enter the Promotion.
5. To enter the Promotion, entrants must register the reference action code as well as their details (full name, postal address, country, phone number, e-mail address) via [www.promo-telex.com](http://www.promo-telex.com). Entrants have to provide details about their purchase (type, quantity, date, country of purchase) and provide bank account details to enable us to carry out the bank transfer. A proof of purchase by sending in a scan of the original invoice issued by an official dealer or reseller is mandatory. Without proof no cash back will be granted. The cashback for the proof of purchase will be done via bank transfer.
6. Product purchases must be made in a participating locations throughout North America. Only purchases in North America are eligible for cashback.
